### ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Sri Veerabadreshwara SC/ST Educational Society, Shimoga District, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri Veerabadreshwara SC/ST Educational Society's B.Ed College, Thalagunda, Shikaripura Taluk, Shimoga-577450, Karnataka for Secondary(B.Ed) course of one year duration with an annual intake of 100 (Hundred) Students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sri Veerabadreshwara SC/ST Educational Society's B.Ed College, Thalagunda, Shikaripura Taluk, Shimoga-577450, Karnataka for conducting Secondary(B.Ed) course of one year duration with an annual intake of 100(Hundred) students under clause 7(12) of Regulations dated 13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - iii) The institution will ensure that Principal and Seven faculty members duly approved by the affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c) Name of faculty members who left or joined during the last, quarter:

 Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

) The affidavit with enclosure submitted along with application.

j) The institution shall be free to post additional relevant information. if it so desires.

 Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
